9. Reports

Sailing Report

With the easing of restrictions, and adhering to RYA guidelines, on the Saturday of our projected Polaris Regatta, we were able to hold a restricted event. Two back-to-back races were run, with five starters, followed by a BBQ. Sonata "Minx", sailed by the Gray brothers, triumphed, and all agreed the temporary escape from the situation very welcome.

Last year's aborted Sailing Calendar contained some changes, and the Sailing Sub Committee has agreed to leave these for 2021. Apart from a couple of dates, confirmation awaited, the Calendar is ready, and will be made available shortly.

This year's Craning-in is scheduled for Saturday 24th April, with the first race on Wednesday 28th. However, this is all dependant to adherence to the guidelines which may disrupt our intentions. The Clyde Cruising Club, who organise the Scottish Series at the end of May, have already drastically altered the event by relocating from Tarbert to the Upper Clyde, to be held at various venues, and with no after sailing social scene. The main Committee agreed to the Sailing Sub Committees recommendation that any Race Entry fees paid for 2020 are carried forward as long as there was nothing else outstanding. While we hope for thing to run smoothly, we will notify members of any disruption to our schedule will be as soon as we can.

Optimism and Pessimism must be overridden by Realism in these straitened times, with the safety and wellbeing of all members paramount, but hope springs eternal for fair winds.

We have gone ahead with the purchase of two Iso's dinghies for the club. We got spare masts, spars, foils and sails with the boats. We got these at the amazing price of £1500 for everything on the condition that the boats are used for young people to improve their sailing from the Iso class association. The valve of the boats and equipment is over £4000.

I am optimistic that cadets will restart in April with the latest Covid regulations. I would also like to suggest that people that have missed a year of cadets can stay on for a extra year; le till they are 17. The purchase of the new boats will help with a increase in numbers if this becomes the case.

Members are asked that. As a result of the Pandemic that it is agreed to suspend that part of Clause five of the Constitution which restricts the time for the Commodore to be in Post to two years currently this states "with the exception of the Commodore who shall not hold office in that capacity for more than two years " and replace it with "Due to the Covid Pandemic the Commodore's period in office is extended to three years and will end at the AGM in 2023, after which the period in office will return to two years.
